# American Nazi Party Bylaws & Expectations

2020

### Introduction

This document details the organization, its structure, and purpose, as well as expectations for those in alignment with our agenda. It is a requirement for all ranks of The American Nazi Party (hereafter referred to as "The Party") to read this document and follow the rules outlined below. This document will also be made public and available for potential new adherents to read before they make a commitment.

# Section I: The Party

### Article I: Purpose

The Party is a political-educational organization, and exists solely for the aim of obtaining the goal stated by the 14 Words: "We must secure the existence of our people and a future for white children." We adhere to the principles and philosophy of National-Socialism as laid out in Adolf Hitler's masterpiece, Mein Kampf.

### Article II: Organizational Structure

The Party closely follows the governmental structure of the NSDAP, headed by a Chairman who is ultimately responsible for the welfare of The Party and for the final word on important decisions. He is assisted by a council of trusted Officers which include the Deputy Chairman (DC).

The DC retains full leadership of The Party in case of the absence of the Chairman, and speaks in place of the Chairman whenever necessary.

The general structure of The Party is hierarchical, and ordered in the following manner:

Chairman > DC > Officers > Members > Official Supporters > Official Sympathizers

Advancement to Full Membership occurs after 1 year in good standing. Good standing is defined as: adhering to National-Socialist values (Section I. Article V), proper conduct (Section II. Article III), consistent payment of dues (Section II. Article I), and active participation in furthering the Party's goals (Section II. Article II). Full membership is not automatic and requires the approval of Party officers.

Communication should occur regularly amongst Official Supporters (OS), and between OS and Members. Meetings should take place via Zoom (audio-only is fine) or other communication method, and whenever possible, local meetings of small-cell regional OS.

Small cell meetings are encouraged for everyone in The Party to attempt to meet up with others in good standing within a reasonable distance.

### Article III: Modus Operandi

The Party's agenda can best be summarized in the in the acronym R.E.O. which stands for Reach, Educate, & Organize. Our efforts must and shall\_be focused on these three areas.

### Article IV: Privacy

The Party takes the privacy and security of those in its ranks to be of the highest importance. We are interested in your action, not in personal details about your life. We care about each one of you, but will not request information that you would be uncomfortable sharing. Furthermore, we suggest you use a "game name" in all your communication within The Party.

We keep a list that includes the first name given to us and initial of last name with state and e-mail address. No other information is retained.

# Article V: Values

As National-Socialists we insist upon our members holding true to the values reflective of our noble heritage. We must lead by example, thus furthering our cause and fostering the very society we desire for ourselves and our children. While these values are elaborated in other documents (ie., What We Stand For), their core can always be found in the 14 Words: We must secure the existence of our people and a future for White children.

### Article VI: Joining & Leaving

In order to join as an Official Supporter (OS), everyone is required to fill out an application which is easily available on our website and related materials.

If one no can no longer contribute towards The Party's goals because of new ideological disagreements, it is expected that they communicate their resignation to the Chairman. All their information will be immediately deleted.

Returning to The Party after resigning from it will require the submission of a new application, accompanied by a letter-of-explanation to the Chairman, who has the final say in such matters.

### Section II: Expectations

#### Article I: Dues

Payment of dues is required for everyone, unless special circumstances (approved by the Chairman) merit an exemption. Dues may be paid monthly, semi-annually, or annually, and this schedule must be communicated and approved by the Chairman or Deputy Chairman.

Non-payment of dues (exclusive of pre-approved exemptions) can result in suspension or loss of Official Supporter/Member status.

#### Article II: Active Contribution

This is not a spectator sport, but a team, and all ranks are expected to work towards the common goals of The Party.

It is expected that each person within The Party will find their niche method of activism and develop that skill in line with the goals of REO.

Anyone in The Party that does not contribute in some way must be removed from our ranks. The Party cannot afford to carry dead weight, for we believe it is better to have a smaller organization of committed individuals than large numbers with minimal action.

It is expected that each person in The Party will take initiative on their own towards productive and consistent activism. We simply cannot afford the time and energy to sustain individuals who need their hands held for every minor task.

### Article III: Behavior & Conduct

We are National-Socialists, and we should hold ourselves to a much higher standard than the average population. The Party will not accept and allow any unlawful behavior or talk promoting such activity. We must live out our values as detailed in Article V of Section I, and be seen as pillars of decency, honor, and respect in our communities. We must be professional in all that we do. We must dress well, speak well (limit slang and foul language), be friendly & courteous to those we deal with on a regular basis.

We do not engage in any public demonstrations or street theater for the amusement of the masses at this time.

The Party strongly recommends against displaying any insignia related to National Socialism on your home or person. Our purpose is to inspire, not to incite, as outlined in REO. Members may best decide what is appropriate for their specific circumstances, but must also understand that anything that reflects poorly on The Party harms our cause and may be grounds for dismissal.

### Article IV: Other Organizations

The Party is not affiliated or associated with any other organization or entity.

Individual members and supporters of The Party who are affiliated with other organizations must keep such other memberships and affiliations completely separate from The Party and under no circumstances act as a representative of The Party without the prior authorization of the Chairman.

Many organizations claiming to have a similar goal or worldview to The Party have had their 15-minutes of fame, only to be exposed as frauds or riddled with scandal. For this reason, as well as having some similarities in ideology while using a methodology which we believe to be harmful to our purpose and goals, concurrent membership in the National Socialist Movement (NSM88) is not allowed while an Official Supporter or Member of The Party.
