--PREFACE--

The lengthy report on the Gaza genocide that dominates this issue of *TWW* is necessarily exhaustive due to the looming legislative proposals, here and in Europe, which will ban any and all criticism of Israel, Jews, the Holocaust®, anything remotely construed as antisemitic. Even strict scholarly research about or impinging upon Jewry will be forbidden –unless authorized by a Jewish oversight council. Taking advantage of the vicious Hamas terror attack on October 7, Israel is milking world sympathy for all they can squeeze out of it. But as the horrors of Gaza and Jew abuse of Palestinians in the West Bank leak out into world media, the acceptance of Jewish behavior only feeds a new or renewed disgust for the entirety of Jewry.

As National Socialists we cannot relegate the Jewish question to a political back burner, to turn down the heat of our criticism of Jews in order to appear more “palatable” to White folks taught to regard Jews as sainted victims who have earned their own country, who are beyond all criticism, who are the world’s conscience in a quest for peace and brotherhood and social justice. We ignore the Jewish question at our own peril.

A recent biopic makes atomic scientist J. Robert Oppenheimer into a kind of pathological psycho-hero. Truth be told, without data from captured German atomic research after the debacle of May 8, 1945, Oppenheimer and his almost exclusive Jewish gang of bomb builders would not have been able to incinerate thousand of Japanese in Hiroshima and Nagasaki. Oppenheimer expressed absolutely no remorse for his hand at searing Japanese men, women and children, yes despite his “Now I am become death” showbiz stunt. His real regret was getting the bomb too late for nuking all of Germany. He and Jews Einstein, Edward Teller, Leo Szilard and Eugene Wigner proposed to Roosevelt that Germany be seeded with cesium, rendering all Germans sterile so the evil militaristic Krauts would disappear in a couple generations.

That Jew bloodlust evident in Japan and the Nuremberg trial prosecutors and judges is but the merest reflection of all Jewish history. For many centuries Jews were controlled, ghettoized, allowed to engage in business and financial schemes of every conceivable iteration, but never given the instrumentalities of power. Now in their own state, armed to the teeth by America and Europe, the old Biblical vengeance of the Jews is revealed not via manipulation of finance and thus politics and proxy wars, but by their very own naked sword.

Today, December 12, the Israeli IDF forces blew up a UN school where thousands of Palestinian civilians sought shelter. The video posted by the IDF shows the explosion accompanied by cheers and singing from the Jew troops. It is the location where several days before male civilians were rounded up, stripped, blindfolded, beaten, tortured, then reappeared as “surrendering” Hamas fighters. Since World War Two the entire world has groaned under the glut of Jewish and liberal oburgation ordering humanity to embrace tolerance, diversity, brotherhood, multiculturalism, and assorted other impossible utopian virtues. The blood-soaked depravity of the Jewish mind as graphically demonstrated by the Gaza genocide puts the lie to all this tedious, unreasonable Jewish scolding. What is actually desired by these exhortations is putting up with the damned Jews, their domination of pop culture, news media and finance, the perversions of Harvey Weinstein and Woody Allen, the Wall Street thieves Ivan Boesky and Michael Milken, to name a very few.

Jewish depravity has long been evident in the West Bank, where illegal Jew settlers attack, rape, and often kill Palestinians whose families have occupied their homesteads for thousands of years. Megan Stack of the *NY Times* (12/10/23) reports on just one typical incident of Jewish frenzy:

After Hamas unleashed the fateful storm of atrocities upon Israeli civilians on Oct. 7, Mr. Amro noticed his settler neighbors had started wearing military uniforms and teamed up with the soldiers in hybrid militias. I heard the same thing from Palestinians in other parts of the West Bank, as well as from human rights groups — the line between settlers and soldiers, it seems, has never been so muddy.

Mr. Amro was walking home on Oct. 7 when he was seized and taken to a nearby military trailer by one such group, he said. The soldiers and settlers beat and kicked him, spat on him and staged mock executions. The men were gleeful, Mr. Amro said, filming videos of his torture and playing music. At one point, Mr. Amro said, his next-door neighbor taunted, “See what I can do to you?” and then punched him in the face. Mr. Amro also said that one of the soldiers called him “my bitch” and threatened to force him to perform oral sex. After 10 hours of torment, when the group finally took him back to the road, naked except for a t-shirt. Mr. Amro anticipated a bullet in the back as he walked away.

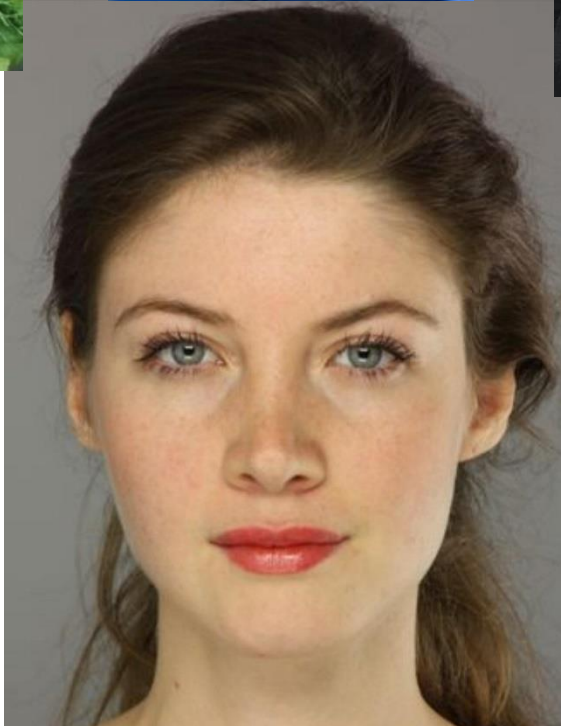
“I was telling myself, ‘If I am going to die, if they want to kill me, I will show them I’m not afraid,’” Mr. Amro told me. He asked for a jacket, he recalled, hoping his captors wouldn’t realize he was shivering in fear. But the gunshot didn’t come. Mr. Amro went home and resumed his usual harrowing existence. Later in October, another problem: Soldiers evicted Mr. Amro from his house in what he understood as a punishment for hosting visitors. He was expelled to the Palestinian-controlled part of Hebron, known as H1, and spent more than two weeks arguing to come back.

When he finally made it back home, he found a scene of vandalism and wreckage. He found a video on Instagram in which a settler had filmed himself roaming around the house.

Thousands of these triumphant Jew settler torture videos are online. Many of a twisted, violent sexual nature conceivable only in a Jewish mind. So awful I do not want to link them here, out of respect for the victims.

Having access to many more pictures and videos from Palestinian pool reporters inside Gaza, I am repeatedly amazed by the number of light-haired, blue-eyed people suffering unspeakable torment in Gaza and the West Bank. These are Circassian Arabs. When blond blue-eyed Lawrence of Arabia was captured by the Turks, due to his fluency in Arabic he was mistaken for a Circassian, not an Englishman, to his great fortune regarding his life, but not his dignity. He was raped by a Turkish commanding officer. A Circassian portraits sampling is on the next page.

All these symptoms of decay must be attributed to the lack of a definite and uniformly accepted worldview, and the subsequent general uncertainty of attitude toward the great questions of the time. This accounts for the habit of doing everything half-way, beginning with the educational system, the reluctance to undertake responsibilities, and finally, the cowardly tolerance of recognized abuses. Humanitarian garbage became the fashion. And in weakly submitting to these aberrations and sparing individual feelings, the future of millions was sacrificed.

An examination of the religious situation before the war shows that the general process of disintegration was growing. A large part of the nation itself had, for a long time already, ceased to have any convictions of a uniform and effective worldview. In this matter, the main point was by no means the number of people who renounced their church membership, but rather the widespread indifference. While both Christian denominations maintain missions in Asia and Africa in order to win new followers –with only modest success compared to the growth of Islam– these same denominations were losing millions and millions of adherents at home in Europe. These former adherents either gave up all religion or adopted their own interpretation. The consequences, particularly in morality, are not good.

It must be noted too that the attack on the dogmatic foundations of the various churches became increasingly violent. And yet our world would be inconceivable without the practical existence of a religious faith. The great masses of a nation are not philosophers. For the masses of people, faith is the only basis of morality. The various substitutes that have been offered haven't shown any results that would justify replacing existing faiths.

But if religious teaching and faith are accepted by the masses, then the absolute authority of religious doctrines would be the foundation of all practical effort. There may be a few hundred thousand superior men who can live wisely and intelligently without depending on social norms, but millions of others cannot. For them, the role of social norms corresponds to everyday life in the same way that laws relate to the state, and dogma to religion. The purely intellectual idea is, of itself, a variable thing that is subject to endless interpretations. It's only through dogma that it has a precise and concrete form, without which religion couldn't become a living faith. Otherwise the intellectual idea would never become anything more than a mere metaphysical concept, or rather, a philosophical opinion. The attack against dogma is comparable to an attack against the general laws on which the state is founded. Such a political attack would lead, in the end, to complete political anarchy if it were successful; in the same way, an attack on dogma would lead to a worthless religious nihilism. A political leader shouldn't estimate the value of a religion by taking its shortcomings into account, but rather by virtue of a demonstrably better substitute. Until such a substitute is available, only fools or criminals would think of abolishing that which exists.

Undoubtedly no small amount of blame for the present unsatisfactory religious situation must be attributed to those who have encumbered the religious ideal with purely material accessories; this gave rise to an utterly futile conflict between religion and so-called exact science. In this conflict, victory will nearly always be on the side of science, though perhaps after a hard struggle. And religion will thus suffer heavily in the eyes of those who can't penetrate beyond mere superficial knowledge.

But the greatest damage of all has come from the misuse of religion as a means to serve political interests. In truth, we can't attack hard enough those wretched criminals who would prefer to make religion provide political, or rather business, services for them. The impudent liars who do this profess their faith before the whole world in stentorian tones, so that all sinners may hear –not that they are ready to die for it, but rather that they may live all the better. **They are ready to sell their faith for a single political swindle.** For ten parliamentary mandates, they would ally themselves with the Marxists, who are the mortal foes of all religion. And for a seat in the cabinet, they would enter into marriage with the devil –if the latter hadn't still retained some traces of decency.

The Gold Standard

We are all feeling the vicious pinch in our wallets from inflation. Most of us want to blame Biden and the Democrats and indeed a good part of it all is their reckless spending policies now known as Bidenomics. But in all fairness, it isn't completely their fault.

Before I get into this, I need to explain that regardless of the financial times, whether we're suffering from inflation, depression, recession, or stagflation, wealth is never destroyed. **It is concentrated in fewer and fewer hands.**

Bankers would have us believe that what they do is too complicated for us to understand. Horse manure. It's actually very simple. To keep money in circulation, the Federal government purchases bonds from the Federal Reserve Bank. A one-dollar bond costs one dollar. If somehow the government was able to pay off the national debt in one payment, the economy would collapse. For every dollar in debt we pay off, that same amount of money would be removed from circulation by the Fed. This applies only to the principle, not the interest. That's why the government makes interest only payments every year. This is supposed to keep the money supply stable, but the government spends more and more each year, so they buy more and more bonds and the Fed issues more and more money, which causes inflation. The more money that's in circulation, the less it's worth. That's what causes inflation.

Many are calling for us to return to the gold standard. That means that for every dollar that is issued, it must be backed up with an equal amount of gold. Kind of like those prepaid credit cards you can buy at Walmart. Unless you put money into it, it isn't worth a thing.

Returning to the gold standard would be a tragic mistake. First, the government has no gold reserves. Any gold that is still left in Fort Knox belongs to the Fed, and foreign investors. The government is just storing it for them (for a fee).

Secondly, gold is only so valuable because the supply is limited. According to the US Geological Survey, if all the mined gold in the world was lumped together, it would form a cube of only 75 X 75 X 75 feet. That's right, feet. Not yards, not miles, but feet. If we returned to a gold standard, he who owns the gold determines how much money would be issued. That would be even worse than now.

So, what is the solution? At the outbreak of the Civil War, there was no Fed. Money was issued by regional banks. Naturally, they charged the government a fee for this. Lincoln investigated obtaining loans to finance the war. He had his financial advisors checked several banks but was unhappy with the rate of interest they were asking. He asked his advisors if they had an alternative solution. One came up with a brilliant idea. Simply get Congress to authorize the Treasury Department to print up their own money. That is just what happened. The front of each bill looked like the bank notes people used for money, but instead read Treasury Note. Why not? If the government can issue a bond which increases the debt, they can issue their own money with no debt. The backs of these Treasury Notes were different from bank notes. They were a bright green in color. Very soon, they became known as "greenbacks". Also printed on each one was the words "This note is legal tender for all debts public and private". That meant that no person or business in the United States could refuse to accept greenbacks as payment. They calculated how many greenbacks they could put into circulation without undue strain on the economy. How many was that? I have no idea, but the citizens immediately accepted greenbacks as currency. This of course was of grave concern to the bankers. They no longer had a monopoly on the issuance of money. They had to act. However, because of the war, they had to wait. It would have been bad PR for them if they tried to pressure Lincoln into removing greenbacks from circulation during wartime.

The people were clamoring for more greenbacks. Despite the war, prosperity seemed to be returning to America. The bankers had to bide their time. When the war ended, the bankers immediately started pressuring Lincoln to remove greenbacks from circulation. They claimed it was ruining the economy. Yes, it was ruining the economy for the bankers, but the people were prospering. Lincoln ordered more greenbacks into circulation and ordered the removal of the same amount of bank notes to balance the economy. Prosperity continued. In a few months, Lincoln was dead. Coincidence? I think not. It is quite likely that the bankers put Booth up to assassinating Lincoln.

When Andrew Johnson took over as president, the bankers started to work on him. He did not totally cave in to their pressure. He stopped the printing of new greenbacks but refused to recall those already in circulation. On two different occasions, Johnson was impeached on trumped up charges, but beat the rap both times. The bankers didn't think they could get away with another assassination so soon, so they tried impeachment. They failed.

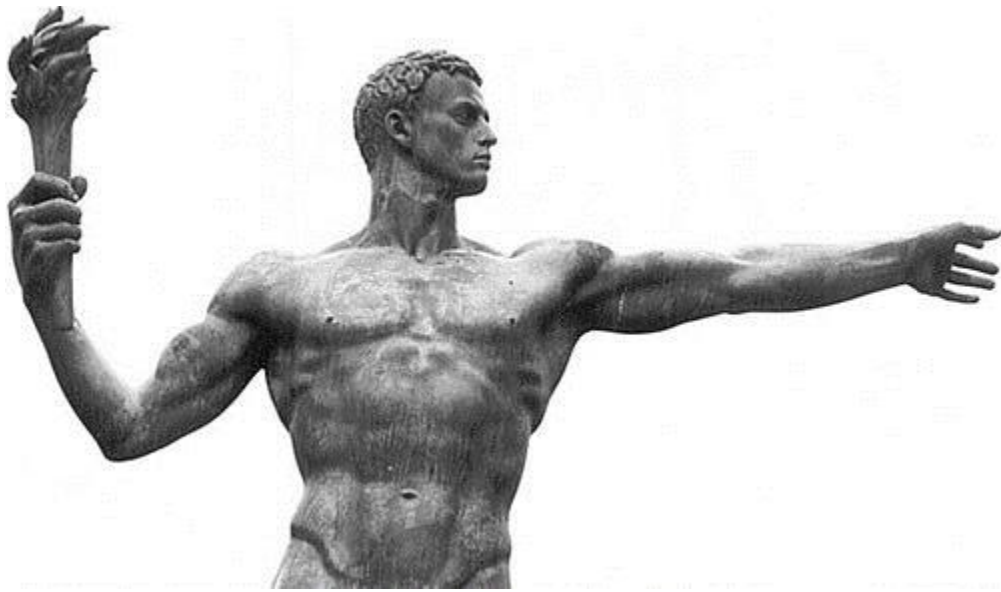
Greenbacks remained in circulation until well into the 20th Century. When the Federal Reserve Bank was started in 1913, its first two actions were to outlaw the use of silver as money and recall all greenbacks from circulation. Why did they do this? As I previously said, gold is so valuable because it is limited in quantity. That also means it's easier to maintain control of it. There is 50 times more mined silver in the world than gold, so while it isn't as valuable, it is much harder to control. Back then, coins were made mostly of silver except the penny which was copper, and the nickel which was, no duh, made of nickel. The possession of silver was made illegal except for jewelry, silverware, and collector's coins. This law was eventually repealed and although coins are no longer made of silver, if you bring silver to any US Mint they will strike it into coins for you. The same if you bring them gold. As to greenbacks, they were mostly removed from circulation by 1915, although some remained mostly as collector's items. If you ever run across one, it is still legal tender, but you will only get face value for it. You'll get much more at a coin dealer. A mint condition one dollar greenback can fetch around \$200.

Seeing how well the greenbacks worked and how desperate the Fed (which never works for the best interests of the common people) was to get rid of them, the solution to our economic problems begins with nationalizing the Federal Reserve Bank. The nation's central bank should be owned by the government and not private business. The Fed's duties in centralizing large banking transactions, the exchange of foreign currency, and



the setting of interest rates would remain unchanged except these things would be done by the government and not private bankers. The Treasury would oversee the issuance of money through Treasury notes like the old greenbacks. Remember, if the country can issue a bond which is debt, it can issue its own money debt free. If we can recall all Federal Reserve Notes gradually within three years, we can pay off the debt without crashing the economy.

The biggest question is why hasn't this been done? The reason is that the bankers have their talons sunk deep into every tier of government. No one gets elected to high office like the president, congressmen, or senators if the fat cats in the financial industry even think that that person will not play ball. So, our government officials go on year after year blowing a lot of smoke about reducing the national debt when they have no intentions at all of doing anything about it. That way the rich get richer, and the poor get poorer. They get all the money while we get the shaft – as always.

THE JEWISH BLOOD LIBEL

The murderous, bloody brutality rained down upon innocent Palestinian civilians in the Gaza strip, the Jewish retaliation for the October 7 Muslim terrorist attack launched from Gaza against peaceful Israeli settlers in nearby kibbutzes, has achieved what the Gazan Hamas terror plotters intended: a critical eye has been turned upon not only Israel, but the whole Jewish ethos, the Torah justifications of Jewish behavioral excess underscored by the filth revealed in the turgid Talmud; exposure of the secular religion which is the unassailable Holocaust© that grants to all Jews automatic and eternal acquittal of any crime, any business or social transgression.

Most obviously brought to light is something our Führer, invoking Schopenhauer, taught us in *Mein Kampf*: The Jew is the **great master of lies**.

Much of the world believes or at least accepts the Jewish pretext for the genocide in Gaza i.e., the right of self-defense after the Hamas terror attack that killed over 1400 --oh wait, that was corrected by the Israeli government to number approximately 1200, ---no wait, the most recent calculation is more precisely 1147 dead at the hands of savage Islamic beasts, similar adjustments of reduction like the 4 million dead at Auschwitz downsized to 1.5 then 1.2 then finalized at 1.25 million. Geniuses at finance and lending, the Jews get their personnel numbers wrong, time and again. Hamas soldiers of Islam chopped up, beheaded, and burned babies. Great master of lies. On November 30, *The New York Times*, hardly an antisemitic news source, exposed the first of many Jew lies about the Gaza situation. The headline reads:

Israel Knew Hamas's Attack Plan More Than a Year Ago

Here is the *Times* article lead verbatim:

Israeli officials obtained Hamas's battle plan for the Oct. 7 terrorist attack more than a year before it happened, documents, emails and interviews show. But Israeli military and intelligence officials dismissed the plan as aspirational, considering it too difficult for Hamas to carry out.

The approximately 40-page document, which the Israeli authorities code-named "Jericho Wall," outlined, point by point, exactly the kind of devastating invasion that led to the deaths of about 1,200 people.

The translated document, which was reviewed by *The New York Times*, did not set a date for the attack, but described a methodical assault designed to overwhelm the fortifications around the Gaza Strip, take over Israeli cities and storm key military bases, including a division headquarters.

Hamas followed the blueprint with shocking precision. The document called for a barrage of rockets at the outset of the attack, drones to knock out the security cameras and automated machine guns along the border, and gunmen to pour into Israel *en masse* in paragliders, on motorcycles and on foot — all of which happened on Oct. 7.

The plan also included details about the location and size of Israeli military forces, communication hubs and other sensitive information, raising questions about how Hamas gathered its intelligence and whether there were leaks inside the Israeli security establishment.

The document circulated widely among Israeli military and intelligence leaders, but experts determined that an attack of that scale and ambition was beyond Hamas's capabilities, according to documents and officials.

The Israeli government claimed the Hamas terror was a cowardly sneak attack. It wasn't. The Mossad (full Hebrew appellation is "Central Institute for Intelligence and Special Operations"), along with Aman (military intelligence) and Shin Bet (internal security), the vaunted "best intelligence gathering apparatus in the world" was duped, lazy, supercilious. The Hamas plan was just "aspirational," a script for some live action role playing to vent their hate for Jews.

In response to the Hamas attack and to cover their own intelligence blunder, the Jews, armed with American weaponry, have laid siege to Gaza, cutting off all food, water, medicine, utilities, venues of escape. The civilian Gazans are trapped in an open-air prison. Hamas and other Gazan militants, wielding by comparison weapons equivalent to slingshots, are supposedly hunted down by Israel's "precision targeting" to avoid the deservedly maligned cover term "collateral damage."

On October 8 Israel launched a murderous campaign of intentional indiscriminate carpet bombing on Gaza. Antony Blinken, America's weepy Jewish Secretary of State, urged the Jews to avoid that idiotic excuse of "collateral damage." indiscriminately. As of this writing, 20,000 Gazans are known to be killed, 9,800 are children. These numbers cannot take into account the many thousands buried in the rubble of their homes. There is no way, no time safe from bombing, that will allow rescue operations to find those who may still be alive, nor the bodies of loved ones crushed into a pulp. This bloody assault on a caged civilian population is out of all imaginable proportions to the 1,147 Jews murdered by Islamic jihadist Gazans on October 7. US Army officials have declared in disgust that the Israeli bombing frenzy unleashed upon an area from which there is no escape is worse than US carpet bombing in Vietnam and Cambodia, as bad as Hamburg, Dresden, and Tokyo in World War 2.

Indeed, Gaza looks like Dresden after the Allies bombed the German city into a nightmare hell.

Unlike the Allies in World War II, the Israel Defense Forces aren't targeting civilians at all. A cut to IDF soldiers bringing in cardboard boxes from outside the hospital into the MRI room. The next cut has the tour guide soldier claiming “absolute proof” of Hamas presence in and under the hospital. The boxes seen **carried into the hospital by IDF troops** he opens to display more rusty guns. “Incontrovertible truth” he says. The IDF guide then points to a piece of paper taped to the MRI room wall. He says it is a Hamas attack plan. When the Arabic handwriting was translated, it turned out to be a nursing staff work schedule. Critics have raised questions about the credibility of the IDF’s video, highlighting the absence of footage that shows the alleged discoveries actually being made.



Social media users heavily mocked the IDF’s video and what they saw as a far-fetched narrative, with one sarcastically saying: “Imagine you’re a Hamas fighter operating in a huge military base under the hospital, but you decide to hide your weapon behind an MRI machine.” Another said: “Somebody tell them how an MRI machine works and why nothing metallic is stored in its vicinity.”

After the wave of mockery and criticism, Israel deleted the video, which was initially captioned: “No cuts, no edits, just the undeniable truth.” **GREAT MASTER OF LIES.**

Ironically, the IDF reposted the video with several edits and blurs in an attempt to make their narrative more believable.

In the new video, the IDF blurred an image that initially depicted a female soldier as a hostage, claiming her photo was found on a Hamas laptop in the hospital. However, after enhancing the colors of the photo it was revealed to be an image of female Israeli soldier Ori Megidish that the IDF previously claimed to have freed.

A CNN investigation has fueled skepticism regarding Israel’s justification for bombing hospitals and its claims of underground tunnels, as the IDF presented no evidence supporting these

assertions thus far. Israel has a pattern of perpetuating falsehoods to justify its genocide in Gaza and the West Bank. In one instance, a video featuring a woman posing as a Palestinian nurse at Al-Shifa Hospital emerged, accusing Hamas of seizing the facility and stealing crucial supplies. However, the video's credibility crumbled when it was revealed that the bombing sounds in the footage were fabricated, and the woman's accent exposed her as Israeli

One of the most disconcerting fabrications was Israel's claims that Hamas had beheaded 40 Israeli infants. The accusations were even echoed by Joe Biden following his meeting with Israeli PM Benjamin Netanyahu, before Biden's staff quickly retracted the claim and confirmed they had not seen any evidence of it. The London *Guardian* for Nov. 17 published more details about the supposed Hamas underground HQ beneath the Al Shifa hospital. Here the headline:

**IDF evidence so far falls well short of al-Shifa hospital being Hamas HQ
Footage to date fails to prove Gaza complex was nerve centre for attacks on Israel, as
military has claimed**

Prior to their capture of Dar al-Shifa hospital, the Israel Defense Forces went to great lengths to depict the medical complex as a headquarters for Hamas, from where its attacks on Israel were planned.

The evidence produced so far falls well short of that. IDF videos have shown only modest collections of small arms, mostly assault rifles, recovered from the extensive medical complex.

That suggests an armed presence, but not the sort of elaborate nerve centre depicted in animated graphics presented to the media before al-Shifa was seized, portraying a network of well-equipped subterranean chambers.

Even the videos produced so far have raised questions under scrutiny. A BBC analysis found the footage of an IDF spokesperson showing the apparent discovery of a bag containing a gun behind an MRI scanning machine, had been taped hours before the arrival of the journalists to whom he was supposedly showing it.

In a video shown later, the number of guns in the bag had doubled. The IDF claimed its video of what it found at the hospital was unedited, filmed in a single take, but the **BBC analysis found it had been edited.**

There are questions over how much of its graphic presentation of the network under al-Shifa was based on what Israel knew already; **its own architect had built an extensive basement area there the last time Israel directly occupied Gaza, up to 2005.**

**‘Erase Gaza’: War Unleashes Incendiary Rhetoric in Israel
Experts say that inflammatory statements by prominent Israelis are normalizing ideas
like the killing of civilians and mass deportations.**

Shock, grief and pain have cascaded across Israel since Hamas gunmen poured out of Gaza to kill an estimated 1,200 Israeli civilians and soldiers on Oct. 7. So have anger and a thirst for vengeance, which the country’s leaders are verbalizing in language that critics in Israel say often crosses the line into incitement.



“We are fighting human animals, and we are acting accordingly,” said Yoav Gallant, the defense minister, two days after the attacks, as he described how the Israeli military planned to eradicate Hamas in Gaza.

“We’re fighting Nazis,” declared Naftali Bennett, a former prime minister.

“You must remember what Amalek has done to you, says our Holy Bible — we do remember,” said Prime Minister Benjamin Netanyahu, referring to the ancient enemy of the Israelites, in scripture interpreted by scholars as a call to exterminate their “men and women, children and infants.”

Inflammatory language has also been used by journalists, retired generals, celebrities, and social media influencers, according to experts who track the statements. Calls for Gaza to be “flattened,” “erased” or “destroyed” had been mentioned about 18,000 times since Oct. 7 in Hebrew posts on X, the site formerly known as Twitter, said FakeReporter, an Israeli group that monitors disinformation and hate speech. The phrases were only mentioned 16 times in the month and a half before the war.

The cumulative effect, experts say, has been to normalize public discussion of ideas that would have been considered off limits before Oct. 7: talk of “erasing” the people of Gaza, ethnic cleansing, and the nuclear annihilation of the territory.

Incendiary statements are not limited to Israel, of course. Ghazi Hamad, a senior leader of Hamas, vowed on Oct. 24 that the group would wipe out Israel as a country, and appeared to exult in the barbaric acts that his militants had carried out against Israeli civilians. “We are not ashamed to say it with full force,” he said. “We have to teach Israel a lesson, and we will do it again and again.”

But the proliferation of such language by Israelis has opened a debate in Israel, where far-right and ultranationalist politicians were testing the boundaries of acceptable speech even before Oct. 7. Itamar Ben-Gvir, a right-wing settler who went from fringe figure to minister of national security in Mr. Netanyahu’s cabinet, has a long history of making incendiary remarks about Palestinians. He said in a recent TV interview that anyone who supports Hamas should be “eliminated.”

Concerns about the spread of extremist rhetoric are an extension of a political battle within Israel that has been raging all year between Mr. Netanyahu’s ultraright government and a civic opposition, some of whom now worry that it will inure Israelis to the civilian toll in Gaza as the war goes on.

The idea of a nuclear strike on Gaza was raised last week by another right-wing minister, Amichay Eliyahu, who told a Hebrew radio station that there was no such thing as noncombatants in Gaza. Mr. Netanyahu suspended Mr. Eliyahu, saying that his comments were “disconnected from reality.”

Mr. Netanyahu says that the Israeli military is trying to prevent harm to civilians. But with the death toll rising to more than 11,000, according to the Gaza health ministry, those claims are being met with skepticism, even in the United States, which has pressed Israel to allow daily four-hour humanitarian pauses in the combat.

Such reassurances are also belied by the language Mr. Netanyahu uses with audiences in Israel. His reference to Amalek came in a speech delivered in Hebrew on Oct. 28 as Israel was launching the ground invasion. While some Jewish scholars argue that the scripture's message is metaphoric not literal, his words resonated widely, as video of his speech was shared on social media, often by critics.

"These are not just one-off statements, made in the heat of the moment," said Michael Sfard, an Israeli human rights lawyer and author of "The Wall and the Gate: Israel, Palestine and the Legal Battle for Human Rights."

"When ministers make statements like that," Mr. Sfard added, "it opens the door for everyone else."

Yehuda Shaul, co-director of Ofek, a think tank in Jerusalem, has collected 286 statements since Oct. 7 that he classifies as having the potential to incite unlawful behavior. His list includes Eyal Golan, an Israeli pop singer; Sara Netanyahu, the wife of Mr. Netanyahu; and Yinon Magal, a host on Israel's right-wing Channel 14.

"Erase Gaza. Don't leave a single person there," Mr. Golan said in an interview with Channel 14 on Oct. 15.

"I don't call them human animals because that would be insulting to animals," Ms. Netanyahu said during a radio interview on Oct. 10, referring to Hamas.

"It's time for Nakba 2," Mr. Magal wrote on X on Oct. 7, a reference to the mass displacement and flight of Palestinians before and after Israel's creation in 1948, which Palestinians refer to as the "nakba," or "catastrophe."

In the West Bank last week, several academics and officials cited Mr. Eliyahu's remark about dropping an atomic bomb on Gaza as evidence of Israel's intention to clear the enclave of all Palestinians — a campaign they call a latter-day nakba.

On Saturday, the Israeli agriculture minister, Avi Dichter, said that the military campaign in Gaza was explicitly designed to force the mass displacement of Palestinians. "We are now rolling out the Gaza nakba," he said in a television interview. "Gaza nakba 2023."

The rise in incendiary statements comes against a backdrop of rising violence in the West Bank. Since Oct. 7, according to the United Nations, Israeli soldiers have killed 150 Palestinians, including 44 children, in clashes. Jewish settlers, some of whom are armed and informally allied with the military, have killed eight people, one of them a child, according to the United Nations.

Israeli officials point out that Hamas is also active in the West Bank and say that many of those clashes resulted from the military's efforts to root out militants. Three Israelis have been killed in attacks by Palestinians since Oct. 7.

Eran Halperin, a professor of psychology at Hebrew University in Jerusalem, argued that the use of inflammatory language by Israeli leaders is not surprising, and even understandable, given the brutality of the Hamas attacks, which inflicted collective and individual trauma on Israelis.

For the first time since the Yom Kippur War of 1973, he said, Israel's survival hangs in the balance. The country is facing the prospect of a multi-front conflict against Hezbollah and Hamas, as well as a potential uprising in the West Bank.

"People in this situation look for very, very clear answers," Professor Halperin said. "You don't have the mental luxury of complexity. You want to see a world of good guys and bad guys."

"Leaders understand that," he added, "and it leads them to use this kind of language, because this kind of language has an audience."

Casting the threat posed by Hamas in stark terms, Professor Halperin said, also helps the government ask people to make sacrifices for the war effort: the compulsory mobilization of 360,000 reservists, the evacuation of 126,000 people from border areas in the north and south, and the shock to the economy.

But Mr. Sfarid warned that Israel's dehumanization of the people of Gaza could open the door to further discrimination and mistreatment of Palestinian citizens in Israel. It will also make Israelis more inured to the civilian death toll in Gaza, which has isolated Israel around the world, he added. A civilian death toll of 10,000 or 20,000, he said, could seem to "the average Israeli that it's not such a big deal."

In the long run, Mr. Sfarid said, such language dooms the chance of ending the conflict with the Palestinians, erodes Israel's democracy and breeds a younger generation that is "easily using the language in their discussion with their friends."

"Once a certain rhetoric becomes legitimized, turning the wheel back requires a lot of education," he said. "There is an old Jewish proverb: 'A hundred wise men will struggle a long time to take out a stone that one stupid person dropped into the well.'"

The Jewish well is deep and has long been in the world a source of corrosive poison.

The lengthy, detailed *Times* article mentions self-confessed racial Jew supremacist Itamar Ben-Gvir, a disciple of Jewish Defense League Orthodox rabbi Meir Kahane. (Associated Press, Nov. 20, 2023) When Israeli warplanes swooped over the Gaza Strip following Hamas militants' deadly attack on southern Israel, Palestinians say a different kind of war took hold in the occupied West Bank.

Overnight, the territory was closed off. Towns were raided, curfews imposed, teenagers arrested, detainees beaten, and villages stormed by Jewish vigilantes.

With the world's attention on Gaza and the humanitarian crisis there, the violence of war has also erupted in the West Bank. Israeli settler attacks have surged at an unprecedented rate, according to the United Nations. The escalation has spread fear, deepened despair, and robbed Palestinians of their livelihoods, their homes and, in some cases, their lives.

"Our lives are hell," said Sabri Boum, a 52-year-old farmer who fortified his windows with metal grills last week to protect his children from settlers he said threw stun grenades in Qaryout, a northern village. "It's like I'm in a prison."

In six weeks, settlers have killed nine Palestinians, said Palestinian health authorities. They've destroyed 3,000-plus olive trees during the crucial harvest season, said Palestinian Authority official Ghassan Daghlal, wiping out what for some were inheritances passed through generations. And they've harassed herding communities, forcing over 900 people to abandon 15 hamlets they long called home, the U.N. said.

When asked about settler attacks, the Israeli army said only that it aims to defuse conflict and troops "are required to act" if Israel citizens violate the law. The army didn't respond to requests for comment on specific incidents.

U.S. President Biden and other administration officials have repeatedly condemned settler violence, even as they defended the Israeli campaign in Gaza.

“It has to stop,” Biden said last month. “They have to be held accountable.”

That hasn’t happened, according to Israeli rights group Yesh Din. Since Oct. 7, one settler has been arrested — over an olive farmer’s death — and was released five days later, the group said. Two other settlers were placed in preventive detention without charge, it said.

Naftali Bennett, former Israel PM and now a member of Netanyahu’s cabinet, often brags about killing Arabs around his own illegal settlement home. (See *TWW*, Nov. 2023)

‘A mass assassination factory’: Inside Israel’s calculated bombing of Gaza

Permissive airstrikes on non-military targets and the use of an artificial intelligence system have enabled the Israeli army to carry out its deadliest war on Gaza, a +972 and Local Call investigation reveals.

The Israeli army’s expanded authorization for bombing non-military targets, the loosening of constraints regarding expected civilian casualties, and the use of an artificial intelligence system to generate more potential targets than ever before, appear to have contributed to the destructive nature of the initial stages of Israel’s current war on the Gaza Strip, an investigation by +972 Magazine and Local Call reveals. These factors, as described by current and former Israeli intelligence members, have likely played a role in producing what has been one of the deadliest military campaigns against Palestinians since the Nakba of 1948.

The investigation by +972 and Local Call is based on conversations with seven current and former members of Israel’s intelligence community — including military intelligence and air force personnel who were involved in Israeli operations in the besieged Strip — in addition to Palestinian testimonies, data, and documentation from the Gaza Strip, and official statements by the IDF Spokesperson and other Israeli state institutions.

Compared to previous Israeli assaults on Gaza, the current war — which Israel has named “Operation Iron Swords,” and which began in the wake of the Hamas-led assault on southern Israel on October 7 — has seen the army significantly expand its bombing of targets that are not distinctly military in nature. These include private residences as well as public buildings, infrastructure, and high-rise blocks, which sources say the army defines as “power targets” (*“matarot otzem”*).

The bombing of power targets, according to intelligence sources who had first-hand experience with its application in Gaza in the past, is mainly intended to harm Palestinian civil society: to “create a shock” that, among other things, will reverberate powerfully and “lead civilians to put pressure on Hamas,” as one source put it. **An excuse to cause destruction.**

Several of the sources, who spoke to +972 and Local Call on the condition of anonymity, confirmed that the Israeli army has files on the vast majority of potential targets in Gaza — including homes — which stipulate the number of civilians who are likely to be killed in an attack on a particular target. This number is calculated and known in advance to the army’s intelligence units, who also know shortly before carrying out an attack roughly how many civilians are certain to be killed.

In one case discussed by the sources, the Israeli military command knowingly approved the killing of hundreds of Palestinian civilians in an attempt to assassinate a single top Hamas military commander. “The numbers increased from dozens of civilian deaths [permitted] as collateral damage as part of an attack on a senior official in previous operations, to hundreds of civilian deaths as collateral damage,” said one source.

“Nothing happens by accident,” said another source. “When a 3-year-old girl is killed in a home in Gaza, it’s because someone in the army decided it wasn’t a big deal for her to be killed — that it was a price worth paying in order to hit [another] target. We are not Hamas. These are not random rockets. Everything is intentional. **We know exactly how much collateral damage there is in every home.**”

According to the investigation, another reason for the large number of targets, and the extensive harm to civilian life in Gaza, is the widespread use of a system called “Habsora” (“The Gospel”), which is largely built on artificial intelligence and can “generate” targets almost automatically at a rate that far exceeds what was previously possible. This AI system, as described by a former intelligence officer, essentially facilitates a **“mass assassination factory.”**

According to the sources, the increasing use of AI-based systems like Habsora allows the army to carry out strikes on residential homes where a single Hamas member lives on a massive scale, even those who are junior Hamas operatives. Yet testimonies of Palestinians in Gaza suggest that since October 7, the army has also attacked many private residences where there was no known or apparent member of Hamas or any other militant group residing. Such strikes, sources confirmed to +972 and Local Call, can knowingly kill entire families in the process.

In the majority of cases, the sources added, military activity is not conducted from these targeted homes. “I remember thinking that it was like if [Palestinian militants] would bomb all the private residences of our families when [Israeli soldiers] go back to sleep at home on the weekend,” one source, who was critical of this practice, recalled.



And if all that were not enough, it has been confirmed that the IDF uses anti-personnel cluster bombs and white phosphorus against civilian targets, both violations of international law that Jewish politicians support except when the law is invoked against Israel.

The headline for the December 2 *Arkansas Times* reads:

“Report suggests Israel used Arkansas-made white phosphorus shells in Gaza.”

← On Oct. 11, streams of white smoke descended from the sky in Gaza City after an Israeli munition exploded above a hotel near the harbor. A similar squid-like plume erupted above the Gaza City neighborhood of Zeitoun that same day.

Two days earlier, reporters photographed Israeli soldiers near the Israel-Gaza border standing alongside a long-range artillery weapon and artillery shells containing a substance consistent with the smoke plumes seen in Gaza on Oct. 11: white phosphorus, an incendiary material whose use in densely populated civilian areas is prohibited by international law.

While Israel denies using white phosphorus in Gaza, evidence suggests otherwise. Markings on the white phosphorus munitions photographed Oct. 11 indicate they were manufactured at Arkansas’s **Pine Bluff Arsenal**, the only remaining manufacturer of white phosphorus munitions in North America. You can see the photo in this [recent report from the human rights group Amnesty International](#).

Brian Castner, a weapons investigator at Amnesty International, told the *Arkansas Times* his group had “verified several videos that almost certainly show that white phosphorus smoke projectiles were used in Gaza.”

The videos, posted to social media in October, have been widely reported on by major news outlets.

A spokesperson for the Israel Defense Forces (IDF) said in a statement in October that “the current accusation made against the IDF regarding the use of white phosphorus in Gaza is unequivocally false. The IDF has not deployed the use of such munitions.” White phosphorus is a chemical substance that self-ignites upon exposure to oxygen and burns until it is deprived of oxygen, producing long-lasting, rapacious fires and resulting in excruciating injuries. **Sometimes, buildings struck by white phosphorus will burn continuously for weeks and victims’ burns will reignite after medical dressings are taken off.**

White phosphorus munitions are not outright prohibited by international humanitarian law, but their use is limited to specific situations. Militaries are supposed to use white phosphorus only as a means of illuminating the battlefield, providing a smokescreen for military troops on the ground and signaling targets — not as a weapon. Because it is so highly flammable, white phosphorus is subject to Protocol III of the Geneva Conventions, which prohibits the use of incendiary weapons against civilian targets and the use of air-delivered incendiary weapons in densely populated civilian areas.

And the damage it can cause is severe. Because white phosphorus is fat soluble, it burns through flesh and penetrates deep tissue. It is often absorbed into the bloodstream and can lead to organ damage and failure. The smoke it emits is noxious to breathe. The fatality rate of even minor burns from white phosphorus is high, and injuries associated with the substance are painful and can become worse over time, especially without medical attention.

The IDF used white phosphorus munitions in “Operation Cast Lead,” the Israeli offensive in Gaza in 2008 and 2009. In the aftermath of the 22-day war, Amnesty International and Human Rights Watch delegates found white phosphorus wedges — often still burning — strewn across Gaza City. (The IDF initially denied using white phosphorus during Operation Cast Lead; it later admitted to using the munitions but said it had done so within the bounds of international law.) Amnesty International delegates also found fragments of white phosphorus artillery shells at a United Nations field operations headquarters, where the resulting fire destroyed millions of dollars’ worth of humanitarian supplies, and conducted numerous interviews with civilians who witnessed and/or suffered injuries from white phosphorus.

According to markings on the shells, the munitions were manufactured at the Pine Bluff Arsenal in October 1991. Originally named the Chemical Warfare Arsenal, the Pine Bluff Arsenal was established in 1941. At one time it was home to a network of facilities and laboratories that developed, tested, and stored chemical and biological weapons. After the U.S. acceded to an international arms control treaty on chemical weapons in 1997, it committed to destroying and stopping production of most of its chemical weapons. The last of the chemical weapons stored at the Pine Bluff Arsenal were destroyed in 2010.

Today, the arsenal “serves a critical need for the domestic production of illuminating, infrared, phosphorus and smoke munitions,” according to its website. “It serves as the group technology center for illuminating and infrared munitions and is also the only place in the Northern Hemisphere where white phosphorus munitions are filled.”

The artillery shells photographed on Oct. 9 and included in the recent Amnesty report bear markings that indicate they were assembled and loaded at the Pine Bluff Arsenal in September 1991. According to a U.S. Army document cataloging types of ammunition, each shell contains 116 felt wedges soaked with white phosphorus. After being fired into the air, a charge within the shell discharges the wedges, which then ignite upon contact with the air and generate thick, white smoke that flows downward as they fall to the ground. When deployed by an artillery weapon, such as a howitzer, they can cover an area as large as a football field.

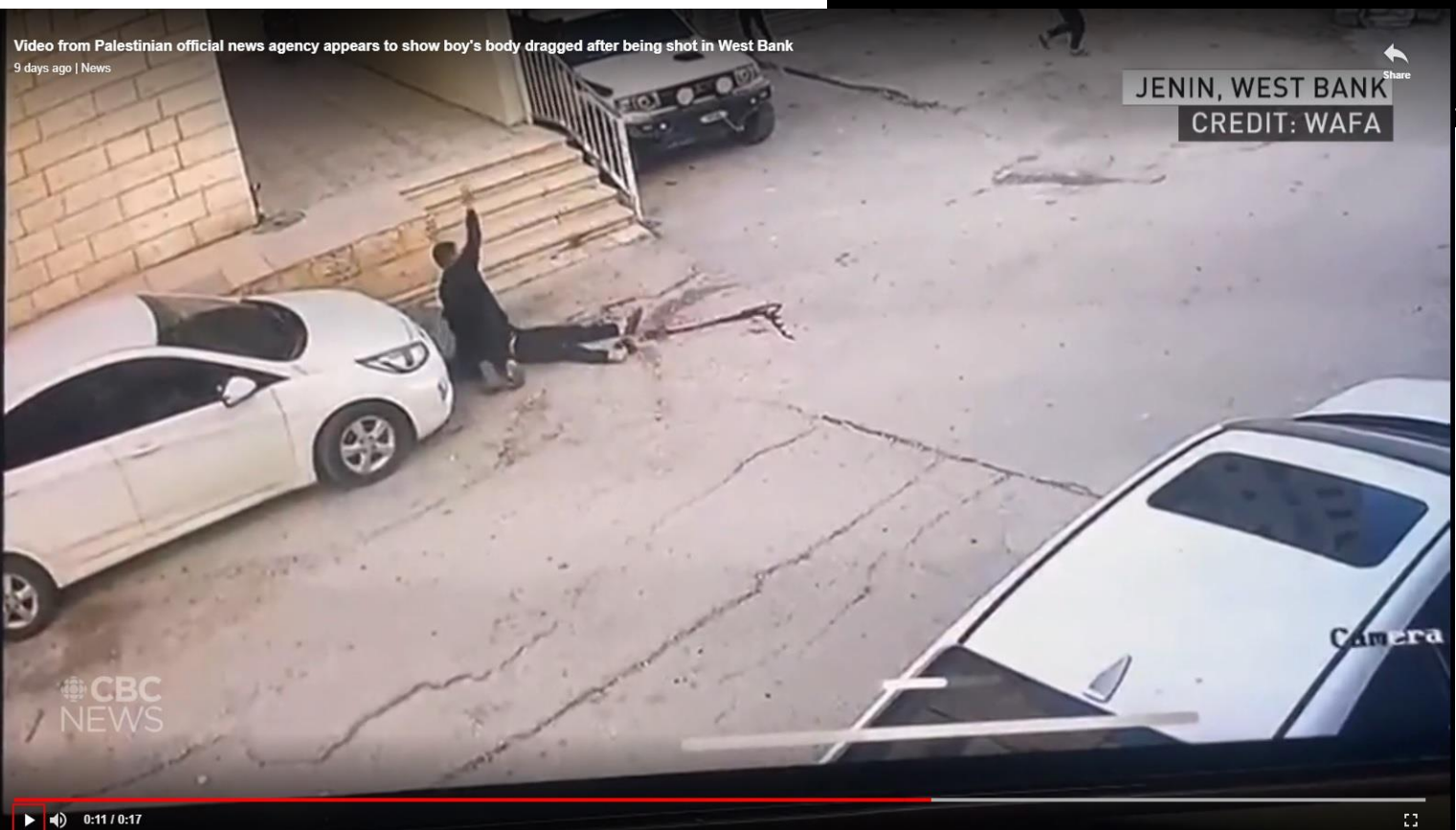

There are currently more than 11,000 Palestinians, most from the West Bank, held in intentionally brutal and filthy Israeli jails under the edict of “administrative detention,” without charge or trial, isolated from family and legal counsel, held for days, weeks, months, some for more than 20 years. **STRIPPED, BEATEN AND BLINDFOLDED:
NEW RESEARCH REVEALS ONGOING VIOLENCE AND ABUSE OF PALESTINIAN
CHILDREN DETAINED BY ISRAELI MILITARY**

Palestinian children in the Israel military detention system face physical and emotional abuse, with four out of five (86%) of them being beaten, and 69% strip-searched, according to new research by Save the Children. Nearly half (42%) are injured at the point of arrest, including gunshot wounds and broken bones. Some report violence of a sexual nature and some are transferred to court or between detention centres in small cages, the child rights organisation said.

The new research comes as the UN Special Rapporteur on the situation of human rights in the Palestinian territories occupied since 1967 presents evidence today to the Human Rights Council on Palestinian children in detention. It is estimated that there are between 500 and 1000 children held in Israeli military detention each year.

Save the Children says these practices are a major and long-standing human rights concern and is calling for the Government of Israel to end the detention of Palestinian children under military law and their prosecution in military courts.

Save the Children and a partner organisation consulted 228 former child detainees from across the West Bank, detained from between one and 18 months, and found that most children are beaten, handcuffed and blindfolded during arrest. They are also interrogated at unknown locations without the presence of a caregiver, and are often deprived of food, water and sleep, or access to legal counsel, according to the research. **The main alleged crime for these detentions is stone throwing, which can carry a 20-year sentence in prison for Palestinian children.**

Khalil*, who was detained when he was 13, said that he did not receive essential healthcare:

"I had an injury in my leg, I had a cast, and had to crawl to be able to move. I felt my body being torn apart. I had no canes to help me walk, I kept asking soldiers for help during the transfer, but no one helped me."

The new research follows Save the Children's 2020 report "Defenceless" and finds that the impact of physical and emotional abuse during detention has soared, with profound consequences on children's ability to recover.

Khalil* continued: *"The soldier threatened to kill me when he arrested me for the second time. He asked me, 'Do you want the same fate as your cousin?' as he had been killed. He promised me that I would have the same fate and die, but that he would send me to prison first. He told me that he's coming back for me – and every day, I wait for that day to come."*

Some children reported that they believed different types of abuse were intended to push them to admit things that were untrue in order to incriminate others, including family members.

Yasmeen*, the mother of Ahmed* detained when he was 14, said: *“During interrogation, they convinced Ahmed* to tell on his brother in exchange for his release. He was naive and didn’t understand what was happening. He said what they told him to say; a few days later, they came to our house and arrested my other son.”*

Save the Children’s new consultation showed that:

- During arrest, 42% of children were injured, including gunshot wounds and broken bones, and 65% of children were arrested during the night, mostly between midnight and dawn. Half of all arrests took place in the children’s home.
- The majority of children experienced appalling levels of physical and emotional abuse, including being beaten (86%), being threatened with harm (70%), and hit with sticks or guns (60%).
- Some children reported violence and abuse of a sexual nature, including being hit or touched on the genitals and 69% reported being strip searched.
- 60% of children experienced solitary confinement with the length of time varying from one 1 day to as long as 48 days.
- Children were denied access to basic services, 70% said they suffered from hunger and 68% said they didn’t receive any healthcare.
- 58% of children were denied visits or communication with their family while detained.
- The majority of children detained are boys – a trend reflected by the survey, with boys representing 97% of the respondents.

Children are increasingly unable to fully return to their normal life following release from detention, with the number of children having frequent nightmares rising from 39% to 53% and those suffering from insomnia or difficulty sleeping rocketing from 47% to 73%, compared to the children surveyed in 2020.

Lana* the mother of Mohammed* who was detained when he was 14, said: *“After my son was released, he wanted to stay by my side and sleep next to me. He refuses to leave the house. It has been a challenge for us; I feel that he is traumatized. He was arrested Tuesday night, now every Tuesday he feels they are coming for him.”*

Save the Children’s research also showed how children’s care and hope for the future decreased from 96% in 2020 to 68% in 2023, an alarming increase in a context with limited psychosocial support available.

Jason Lee, Save the Children’s Country Director in the occupied Palestinian territory, said: *“Each year approximately 500-700 Palestinian children come into contact with the Israeli military court system; they are the only children in the world to experience systematic prosecution in military courts. Our research shows – once again - that they are*

subject to serious and widespread abuse at the hands of those who are meant to be looking after them.

“There’s simply no justification for beating and stripping children, treating them like animals or robbing them of their futures. This is a child protection crisis that can no longer be ignored. There must finally be an end to this abusive military detention system.”

Save the Children is calling on the Government of Israel to respect all children’s rights and international law. No children should be prosecuted in military courts or any court that lacks comprehensive fair trial rights and juvenile justice standards. Save the Children is calling for an immediate moratorium on Israeli military authorities arresting, detaining and prosecuting children. (from Save The Children.net)

Just as Netanyahu cites the Torah/Old Testament to define Palestinians as the new Amalek, a tribe slaughtered by Jews in ancient times, obliterated root and branch, men, women, children, infants, livestock, tilled soil, structures, writings, artwork, wagons, tools....everything, utterly everything annihilated in righteous furor by virtuous, god-fearing ancient Hebrews, so do many Jews use the Fifth Book of the Torah to justify sexual perversion and prurient appetites.

And if you do not want her, you shall send her out on her own; you shall not sell her at all for money, you shall not treat her as a slave, **because you violated her.**

And yet another wrinkle to this Jewish terror: Jew supremacists in Israel and in the Diaspora are looking to use the Gaza genocide as a spur to restore Jewish Samaria, today known as the West Bank. IDF forces have stepped up the number and duration of raids in West Bank Palestinian towns and villages. Homes are routinely bulldozed, streets are torn up and made impassable, water and sewer infrastructure is wrecked. All intended to get the Palestinians out. If murder, intimidation, bulldozing homes is not enough, the Jews humiliate Palestinian men whose manhood is a proud birthright they most fiercely protect. In front of their wives and children, men are stripped, beaten, spat upon by IDF troops, a psychological terror method Jews are

particularly good at. Such an event occurred on December 7. More than 100 Palestinian men detained by Israeli forces were stripped to their underwear, blindfolded and made to kneel on a street in northern Gaza, according to images and videos widely circulated on social media and confirmed by the Israeli army. The men were shown with their heads bowed as they were guarded by Israeli troops in the video, which has drawn condemnation. Al Jazeera's Alan Fisher, reporting from occupied East Jerusalem, said on Friday that the images echoed the history of the region, where stripped men are taken to unknown locations. CNN has asked for explanation from the IDF, but there has been no response. Most of the men were sheltering with their families in two UN relief agency schools. Asked about the video, a spokesman for the Israeli government told the BBC the men detained were **all of military age** and had been "discovered in areas that civilians were supposed to have evacuated weeks ago." Another Jew lie. According to Fisher, one man was with his two **under military age** sons, 13 and 15, all three of them were rounded up. Another detainee is a well-known Palestinian journalist; two men are UN relief agency employees. The captive men were transported to Israeli torture/interrogation stockades in military trucks. On December 8, the negro deputy UN delegate from the United States, Robert Wood, vetoed an otherwise unanimous Security Council vote to demand a ceasefire in Gaza. Wood complained that the UN has not issued sufficient condemnation of the October 7 Hamas attack. "And as of

today, Hamas continues to pose a threat to Israel and remain in charge of Gaza. That is not a threat that any one of our governments would allow to continue to remain on our own borders. Not after the worst attack on our people in several decades. For that reason, while the United States strongly supports a durable peace in which both Israelis and Palestinians can live in peace and security, we do not support calls for an immediate ceasefire. This would only plant the seeds for the next war – because Hamas has no desire to see a durable peace, to see a two-state solution.” (Quoted from online UN transcript)

Wait a minute. **“Worst attack on our people?”** Whose people? The American US rep speaks of the worst attack on our people. Maybe he meant the few American Jewish victims, or maybe he meant Israelis are also our people? Wood did not elaborate when questioned. Consensus is he meant that, for Americans, all Jews are our people.

Israeli UN Ambassador Gilad Erdan told reporters before the Security Council meeting that Hamas had carried out a surprise “barbaric pogrom” and accused the militant group of “blatant, documented war crimes.”

“These animal-like terrorists broke into homes gathered entire families into rooms and shot them point blank, as if they were stomping on insects,” he said. “Grandparents and the elderly, among them Holocaust survivors who endured the Nazis, were violently dragged from their homes, this time by Hamas and taken into Gaza.” Look who’s talking.

Erdan then dismissed the agencies dispensing humanitarian aid to Gaza as “incompetent. They’re losing their supplies to Hamas.” The various humanitarian agency spokespeople denied this, that no relief aid was given to or confiscated by Hamas. The UN relief aid representative shouted at the UN Jew delegate: “Our people could get the relief through to civilians if Israel’s carpet bombing had not killed 130 of our UN personnel!”

As I try to get this issue of *TWW* finished and distributed, another sensational news story breaks, more proof of blatant and frankly clumsy Jewish lies. Just confirmed by CNN and BBC, the initial reports are now congealing into something I can report. The news banner reads:

Israel stages fake Hamas surrender with abducted Palestinian civilians

The men and boys stripped, blindfolded and hauled away on December 7 (details above) have turned up in another IDF video where the men are purportedly Hamas soldiers in the act of surrendering. We are supposed to believe that armed Hamas soldiers allowed themselves to be stripped, tied up, beaten, humiliated in front of wives and children, then they participate in a ceremonial surrender of arms! Aljazeera, BBC and CNN December 10 report as follows:

Israeli forces have staged a video claiming to show Hamas members surrendering in Gaza, in an apparent bid to claim the Hamas leadership is losing control of its fighters.

Israeli forces abducted dozens of Gaza men from the market street in Beit Lahia in northern Gaza on 7 December. The men were forced to strip off their clothes and sit in rows on the street. They were then searched and humiliated before they were taken away in trucks.

Israel claimed the men were Hamas fighters who surrendered and released footage showing one of the nearly naked men walking toward the soldiers with a Kalashnikov rifle

above his head. He then lays the rifle down on the pavement before returning to the large group of captured men.

In the video, the man is holding the rifle in his left hand above his head.

But another video emerged showing the same scene, but this time, the man is holding the rifle in his right hand, showing the scene was recorded multiple times. This suggests Israeli forces staged a fake Hamas surrender using captured Palestinian civilians.



The man shown surrendering with the gun was later identified as Munir Qeshta al-Masry. He is the owner of an aluminum shop in Beit Lahia and has no connection to the Hamas movement.

Many of the other captured men shown in the footage have also been identified as civilians, including *Al-Araby Al-Jadeed* reporter Diaa al-Kahlout along with his brothers and other relatives. The newspaper's editors lost contact with Kahlout on Thursday afternoon before his family informed them of his abduction.

Kahlout's sister said her brother was forced at gunpoint to leave his disabled seven-year-old daughter. She added that the men were taken away, stripped and beaten by Israeli forces. When the video was first released, Israeli army Spokesman Rear Adm. Daniel Hagari claimed that after their surrender, the alleged Hamas fighters complained during interrogation "that the Hamas leadership is disconnected from the tough situation they are in on the ground."

Member of Hamas' Political Bureau Izzat al-Rishq responded in a statement, saying:

"Al-Qassam [Hamas soldiers. -Ed.] heroes do not surrender, and the occupation's lies do not deceive anyone. The Zionist terrorist occupation's display of pictures and scenes of defenseless civilians in Gaza, after detaining them and placing weapons next to them, is

nothing but one of the chapters of an open and ridiculous play, which the occupation has always fabricated in order to create an alleged victory over the resistance men."

The staged surrender video comes as the Israeli media has begun to recognize the Israeli army's significant losses during its ground campaign in Gaza.

Despite its success in killing large numbers of Palestinian civilians in airstrikes, the Israeli army has registered at least 5,000 wounded among its ranks, including 2,000 troops who have been left "disabled" during the two-month-long ethnic cleansing campaign of Gaza. "Israel has never witnessed an event like this before in terms of the number of injured people," the head of the Rehabilitation Department at the Israeli Ministry of Defense, Limor Luria, told Hebrew daily *Yedioth Ahronoth* on 9 December. She added that "58 percent of the soldiers have limb injuries, as they were subjected to the amputation of a leg or arm." The Israeli army claims only 91 soldiers have been killed by the Palestinian resistance in Gaza since the start of the war on 7 October, casting doubt on whether the actual death toll is being kept secret as the Al-Qassam Brigades have documented the daily destruction of Israeli vehicles and squadrons for the past two months.

Israel has nothing to show for its military battles except civilian death, so in desperation it stages this phony surrender. I have seen Hamas soldiers. They are all young and fit, not like this older civilian in the IDF video, forced to play act for Jews. **Great master of lies.**

Two weeks before this ugly Jewish revanchist war began, Israel Prime Minister and indicted fraudster Netanyahu spoke at the UN about the viable future he has brokered for what he called "The New Middle East." He held up a map of the participating countries. Israel was shown as one nation, the Occupied Palestinian Territories expunged. The Palestinians, hostages in their own land since 1948, noticed this point. **The Gaza cauldron finally boiled over.**

And then again, the Israeli intelligence services knew about a planned Hamas attack more than a year ago and did nothing to defuse it, or at least prepare a defense.



But the world will buy, though less often now, the Jew lament that, woe is us, we have been victim to yet another pogrom. Perhaps, but certainly not unanticipated. It was no sneak attack.

For this report, exclusive to *The White Worker*, I have spent many long days combing through mostly mainstream sources. I have taken great pains to report accurately. My research can be readily corroborated online. No fringe websites full of conspiracies as sources, no fanatic promulgators of pious religious passions, no Jew hate preachers or gun nut accelerationist manifestoes, just the purveyors of accepted news. Even the Jewish *New York Times* cannot suppress the bleeding wounds of fact anymore.

I am fortunate to still have contacts at the UN dating back to my days as a freelance translator of witness testimonials submitted to UN investigators in the 1970s and 80s documenting Allied war crimes committed against German and Axis civilians during and long after World War Two. After the war Jews accused Germans of the most gruesome atrocities, mass murder, rape of children, theft of property, a list of tortures all the way down the line to boiling Jews alive. That one reminded me of a sequence in Kurt Vonnegut's *Slaughterhouse-Five*, where two RAF bomber pilots are looking down upon the city of Dresden, a hellstorm, a **holocaust of flames**, chuckling about all those dirty German bladders full of boiling urine. ***Vonnegut was in the city of Dresden when it was bombed, February 13, 14, and 15, 1945***; he came home traumatized and unable to properly communicate the horror of what happened there. *Slaughterhouse-Five* is the product of the twenty years of work it took for him to articulate the experience.

What are the children of Gaza going to tell us if the power to articulate their experiences is ever acquired? If they survive at all. In November, James Elder, UN representative for UNICEF (United Nations Children's Emergency Fund) was able to get inside Gaza with a convoy of humanitarian aid trucks. Elder reported to the UN and via interviews few mainstream news outlets would air except Aljazeera, only snippets aired on CNN and BBC.

The situation on the ground looks desperate, whether it's the physical structure – just seeing apartment block after apartment block, destroyed rubble on the ground, concrete, blown up cars, people fleeing their homes, or whether it's just the look on people's faces, just the trauma, the stress, as if sorrow and sadness have taken root here in Gaza.

It's an immensely difficult time right now, and, of course, this is actually the humanitarian pause. People are recovering from so much over the last seven weeks and are so frightful that things will start again.

But, 1.5 million people have lost their homes, people are in various shelters, hospitals are full of children with the wounds of war.

It's horrendous. Every single child here, I can say that with some certainty, they all will need some kind of mental support. The little boy I was speaking to just half an hour ago in what was a technical college but is now a camp for 30,000 or 40,000 people, lost his mum, lost his sisters in a bombing. He is not even aware yet that his mum had died.

This is the reality.

I've spoken to so many families, and they haven't yet told a child still recovering from the wounds of war that someone else that they love is also dead, that their life is actually even bleaker than they thought.

Hospitals are full. There are overflowing emergency wards with boys and girls with shrapnel wounds, horrendous burns. They're not just on hospital beds inside. These incredible health staff, incredible doctors, nurses are working around the clock and have now run out of space.

It's a war zone. You've got children in car parks and gardens, on beds everywhere. Then, of course, you've got hundreds of thousands of children who are not in school, who are in very overcrowded camps, who are cold, who do not have enough food, do not have enough water, who are now at risk of a disease outbreak. It's a horrendous situation.

Unfortunately, every time I turn around, someone has another story that would break my heart again just now in the last hour. They all stick in my head, particularly those ones who have suffered so much through the fighting.

I was on a bus with children. It had taken four days to get from the hospitals in the north. This little boy had been on a bus for days, with the bottom of his foot blown off. Four days for the flesh to start decomposing, with broken shrapnel burns.

It's beyond any level of understanding how this has happened at such a scale, and therefore, one of the reasons we keep talking so much that this cannot continue.

A little boy, Omar, was seven years old when his family home was hit. His mother was killed, father was killed and Omar's twin brother was killed. Even as I spoke to him, he was able to just share what he's doing. He loves his auntie. She's being amazing and supporting him.

But, he kept closing his eyes, and I was trying to understand why. I asked the auntie why, and she said he's just so terrified that he'll forget what his mother and his father look like. This is his fear now. And so, he closes his eyes because he can't bear the thought that he's lost them in this world, but also might lose them in his imagination. (news.un.org)

The UN contacts put me in touch with a respected English-speaking Palestinian journalist, so well known I dare not reveal his name here (**every critic of Israel** is on some sort of hit list...just ask Susan Sarandon. My press contact does not need guilt by association with a National Socialist!). The pictures and videos I get from the pool reporters inside Gaza are nauseating. On December 10 *The NY Times* again requested permission from Israel to send reporters and cameras into Gaza. Nope. No foreign press allowed. The man whose pool reports I get has been in Gaza since October 8. He has had to move from one hospital to another to avoid being killed in air strikes. (He and his camera crew believe the grounds of hospital complexes are safer...well, they used to think that until they were bombed.). The pool reporters get their material out via portable high-def satellite rigs in backpacks, the cameras and transceivers powered by solar cells. My reporter is now headed to the **sixth** safe zone indicated for evacuees by the IDF. It is a barren wasteland. News coverage told of diseases on the rise and showed how community toilets are made. No food, water, power, medicine, hygiene. The reporter a few nights ago (he reports every hour night and day) was nearly inaudible with laryngitis due to a rash of respiratory sickness running through Gaza. A brave man. Here the latest unbelievable Jew demand, as of 12/10/23:

How Israel is squeezing 1.8 million Palestinians into an airport-sized area

Israel has declared an area smaller than Heathrow Airport as a safe space for Gaza's displaced people to move to.

Every safe zone declared by the IDF is eventually bombed into rubble. After this sixth forced evacuation, there is no place left for the Gazans to go except the Mediterranean Sea.

So often I have been scolded by conservative and White nationalist friends, assuring me I could get further along in my political work if I “just leave all that Jew stuff alone. People don’t get it anymore, they don’t care.” Today people are starting to get it.

Jews claim Israel as a Biblical right. Judea and Samaria were Jewish and must again become Jewish. Strict citizenship (i.e., racial) laws are designed to keep Israel Jewish. No so-called Ethiopian Jews are welcome. But the Jews of the Bible were Sephardic Semites. Most modern Jews (actually beginning back in the 12th Century) are Ashkenazim, a racial mongrelization of Semitic, North African, Anatolian, Slavic and Central Asian bloods. Thus the term “antisemite” really does not apply to modern Jews, for they are barely Semites any longer. Arabs are Semites. Palestinians are Semites. **Not 85% of Jews! The Biblical claims are INVALID.**

I for one never bought into the notorious Jewish blood libel legends, Christian children **-mostly boys-** abducted and ritually killed. Boys were circumcised alive and the blood from the ritual collected to mix into matzo for Passover. Just too ghastly, and typical of tales woven by firelight in medieval times. And then...there is this 2007 book written by Israeli historian Ariel Toaff entitled:

Passovers of Blood: The Jews of Europe and Ritual Murders

Reactions to the book concentrated on the final chapter, which addressed the story of Simon of Trent, a young boy supposedly murdered by Jews in order to extract his blood to be used in making bread for Passover rituals. Roman Catholics commemorated Simon's martyrdom for five centuries, until, in 1965, the Vatican published *Nostra aetate*, which aimed at extirpating antisemitism from the Catholic faithful. The Bishop of Trent signed a decree proclaiming that the accusation against the Jews of that city was unfounded.

Shortly after its publication, press reports were circulated stating that Toaff claims in his book that **there was some truth to the story**, and that Christian children may have been killed by "a minority of fundamentalist Jews of Ashkenazi origin." In an interview with *Haaretz* Toaff said: "Over many dozens of pages I proved the centrality of blood on Passover," Toaff said. "Based on many sermons, I concluded that blood was used, especially by Ashkenazi Jews, and that there was a belief in the special curative powers of children's blood. It turns out that among the remedies of Ashkenazi Jews were powders made of blood." The article also states that: "Although the use of blood is prohibited by Jewish law, Toaff says he found proof of permission given by a highly restricted school of Ashkenazi rabbis to use blood, even human blood. 'The rabbis permitted it both because the blood was already dried, and because in Ashkenazi communities it was an accepted custom that took on the force of law.'" (Wikipedia entry under book's title)

The book was quickly withdrawn, then edited for a new more “truthful” edition.

The Jewish Passover blood ritual dates back to the time when Biblical Hebrews (Sephardic Semites, NOT modern mixed-blood Ashkenazim) were enslaved in Egypt. The Hebrews spoke of imminent liberation by a “deliverer.” The Pharaoh then ordered that all first-born males in Jewish homes shall be slaughtered, thinking the deliverer was newly arrived among the Hebrews.

He did not know it was old Moses. God sent a plague to kill first-born Egyptian males to defeat pharaoh and allow Moses to lead the chosen people to the promised land. The Lord promised that if the Israelites followed His instructions, the plague would pass over them and not hurt their first-born male infants. The Lord told each Israelite family to sacrifice a **perfect male lamb** and paint the blood of the lamb on the doorframe of their houses.

The Jewish blood libel itself had precedents centuries after the death of Moses sometime between 1600 and 1300 BC. The ritual known today first appeared in the 12th Century AD. Children, **mostly boys**, abducted and killed for blood during Passover. True or not, the ritual appears so often in Jewish lore, i.e., sacrificial blood, it seems to be a component of the Jewish psyche, something Jewish scholars find hard to ignore in spite of themselves.

← The penchant for the capture, abuse and murder of young boys by IDF troops reveals one aspect of this awful trait. Sacrifice of a perfect male lamb? The pictures and videos from Gaza suppressed by western media outlets confirm this conclusion. **A blood libel can be raised against the Jews for their frenzied, murderous military campaign in Gaza, thoroughly Jewish in its orgy of bloodlust, the wanton Jewish perpetrators exalted into the realm of holy warriors out to mete justice against those who sin against God's chosen people.**

Nearly 10,000 children sacrificed in Gaza. Scent of Jewish Musk – On November 15, *idiot savant* odd-balled Elon Musk responded to a tweet that said Jewish communities “have been pushing the exact kind of dialectical hatred against whites that they claim to want people to stop using against them.” The post also referenced “hordes of minorities” flooding Western countries, a popular antisemitic political argument.

Twelve days later Musk visited Israel, meeting the country’s leaders and walking through a kibbutz destroyed by Hamas as he tried to calm outrage caused by his endorsement of the antisemitic post.

In a live online conversation on X with Netanyahu, Musk agreed with the prime minister that Israel must destroy Hamas.

“Those who are intent on murder must be neutralized. Then the propaganda must stop,” Musk said. “They’re just training people to be murderers.” He also said Gaza must be made “prosperous.”

“If all that happens, I think it will be a good future,” he said. “I’d love to help.”

Ah yes, he’d love to help, the self-anointed tech savior of Earth, Capitalism, even the planet Mars, his future home, or so he claims. Oh, by the way, the bizarre Tesla CEO was also given an inscribed dog tag by Malki Shem-Tov, the father of Hamas hostage Omer Shem-Tov, during a meeting with Israeli President Isaac Herzog.

Dog tags are common in Israel and have become a symbol of the October 7 attacks, per Reuters. The tag was inscribed with the words: “Our hearts are hostage in Gaza.”

In a reply to a video of the meeting shared by the Israeli president’s office on X, the billionaire said: “I will wear it every day until your loved ones are released.”

He is? -- Elon Musk, once again inserting himself into world politics, sharing seemingly antisemitic posts one day, and then flying across the world to offer support to Israel the next. It's left many wondering where he actually stands on the matter and whether he could be Jewish himself.

It seems like someone who shares conspiratorial posts about Judaism online would have no connection to the religion, but Musk strongly denies claims of antisemitism, **emphasizing his connections to Jewish culture**. During a conversation with whacko right-wing Jew Ben Shapiro, Elon spoke about his ties to the culture, talking about the Hebrew translation of his name, which apparently means "Oak Tree."

Whilst speaking on the topic of religion as a guest on The Full Send Podcast, a narcissistic three-hour long interview, Musk revealed that he was sent to a Hebrew pre-school as a child. However, he clarified that he is not Jewish, suggesting he was only sent there by his father because it was nearby. He did go to Anglican Sunday School but claims to not be particularly religious at all.

Despite not subscribing to any particular religion, Musk has drawn attention to his paper-thin connection to Jewish culture going as far as telling Shapiro, in a narcissistic two-hour interview Sept. 28, that he is "aspirationally Jewish," whatever that means.

He's also made multiple trips to Israel with the most recent being in November. During his visit he offered his support to the Prime Minister, Benjamin Netanyahu, and many Musk fanatics claim this is irrefutable proof that he is not antisemitic.

So a simple answer to the question, is Elon Musk Jewish? Would be no, he wasn't born into a Jewish family, and he does not practice any religion. It's a bit of a stretch to even label him pro-Semitic. He may have some Hebrew education connections which he's made a concerted effort to draw attention to, but despite what Musk wants you to think, he has still allowed, and in some cases promoted antisemitic material on his site. And get this: On December 3, after his contrition visit to Israel Musk posted the Hebrew Proverb:

"How much better to acquire wisdom than gold; to acquire understanding is preferable to silver."

Elon Musk, humble aspirational Jew.

WE WON! – Right wing and White nationalist acquaintances have flooded my email and texting app with blabber about how "we" are winning against the woke lefties and cultural bolsheviks. Recent electoral wins by Dutch rightist Geert Wilders and Argentine libertarian TV showman Javier Milei are signs of other such victories in the offing, according to my enthusiastic message writers. But watch out.

Wilders, whose "Netherlands first" rhetoric and comically, excessively bleached platinum hair, earned him comparisons to Donald Trump, has long made anti-Islam policies a centerpiece of his agenda. Along with demanding a halt to the country's "asylum tsunami," he has called for a ban on Islamic schools, Qurans and mosques. A court found him guilty on insult charges after he led supporters in a chant for "fewer" Moroccans in the Netherlands at a 2016 campaign rally. In 2009, he was refused entry to the United Kingdom on the way to screen his film "Fitna," which associated the Quran with terrorism and sparked international protests.

Following 13 years of a center-right government under former prime minister Mark Rutte, Wilders' Nov. 23 victory was broadly called the country's "biggest political upset" since World War II.



His party's surge came very late in the campaign, and Wilders himself didn't seem to expect the result, reportedly renting a room as party headquarters for election night only three days beforehand.

Okay. Great win on a platform to get immigrant refuse out of the Netherlands. Wilders wants to ban the Quran. And *Mein Kampf*. You see, he is also an Israeli agent. **Wilders in not even White.** His mother is Indonesian. Wilders rejects being labeled as far-right and views himself as a right-wing liberal, while saying he does not want to be "linked with the wrong rightist fascist groups." (BBC interview, 7/31/11)

Wilders lived in Israel for two years during his youth, working on a farm co-op. He has visited the country 40 times in the last 25 years. About Israel he said, "I have visited many interesting countries in the Middle East – from Syria to Egypt, from Tunisia to Turkey, from Cyprus to Iran – **but nowhere did I have the special feeling of solidarity that I always get when I land at Ben Gurion International Airport.**" Dutch public TV channel Nederland2's daily news program "Netwerk" reported that numerous American supporters of

Israel financially supported Wilders' Party for Freedom (PVV) and openly approved of his message towards Islam and Islamic terrorism. Wilders told an audience during the report that "**We in the West are all Israel.**" He has also said "Israel is the West's first line of defense" against what he perceives to be a threat posed by Islam. (Haaretz 9/21/09)

Wilders has made some proposals in the Dutch Parliament inspired by Israeli policies: for example, he supports implementing Israeli-style "**administrative detention**" in the Netherlands, a practice heavily criticized by human rights groups but which Wilders calls "common sense." Wilders displays an Israeli flag in his office.

Many European rightists support Israel in order to avoid the "Nazi" label. Wilders, however, truly loves Israel and emulates its governmental policies.

Milei, the Argentine self-styled "Anarcho-Capitalist" President-Elect's first stop on American visit was the burial site of a Lubavitcher rebbe. His legions of fans call him "crazy" and "The Wig" due to his melodramatic ferocity and unruly mop of hair, while he refers to himself as "The Lion." He thinks sex education is a Marxist plot to destroy the family, views his cloned mastiff dogs as his "children with four paws" and has raised the possibility people should be allowed to sell their own vital organs. He also makes appearances as a Mick Jagger impersonator. Really.

His first foreign trip since winning Argentina's presidential runoff Nov. 19, Milei landed at New York City to visit the burial site of one of Judaism's most renowned leaders and, reportedly, nosh with a former Democratic president (Bill Clinton) before heading for Washington Tuesday for meetings at the White House and Treasury Department.

← Melei visited the burial place of Rabbi Menachem Mendel Schneerson, known as the Rebbe, who led the Chabad-Lubavitch movement for more than four decades before his death in 1994. Schneerson's grave, at a cemetery in Queens, is visited annually by thousands of Jewish people and occasionally by world leaders.

Rabbi Schneerson led Chabad-Lubavitch as the seventh rebbe, or spiritual leader. In those years, he was one of the most influential global

leaders in Judaism, reinvigorating a small community that had been devastated by the Holocaust and pushing for all Jews to become more deeply connected to their faith and **do more good in their everyday lives**. More good for whom? That *Tikkun olam* conceit again?

Milei, baptized Roman Catholic, has been studying the Torah for years and has openly talked about his respect for Judaism. Although he's expressed a desire to convert to Judaism, he hasn't formally started the process, although he says he's close.

Mr. Milei has also expressed staunch support for Israel, both before and after he won the presidential election. During the campaign, he often waved an Israeli flag at his rallies — especially after October 7. He wants to move Argentina's embassy in Israel to Jerusalem from Tel Aviv, emulating a move made by President Trump.

"I don't go to the church; I go to the temple. I don't talk to priests; I have a head rabbi. I study the Torah," Milei said in an August interview. "I'm internationally recognized as a friend of Israel and a scholar of the Torah." (*New York Sun*, Nov. 23, 2023)

A few years ago, Milei was a television talking head that bookers loved because his mad dog, super animated screams against government spending and the ruling political class boosted ratings. At the time, and up until mere months ago, hardly any political expert believed he had a real shot at becoming president of South America's second-largest economy.

The so-called nationalist government in Poland was voted out for a center left coalition. Anti-immigration and anti-abortion laws were not enough to save it. What good are they if a party does nothing to sustain, improve, and develop a people. The Polish rightists secured capitalist dominance, no effort to form a real sense of community. **We won?** Accepting any jerk who mimics calls for White solidarity via some compromised anti-immigrant policy and similar conservative shibboleths is as sure a racial suicide as that fostered by woke governments.
